**ELECTION OF PRESIDENT, JUNIOR VICE PRESIDENT, MĀORI VICE PRESIDENT AND
EXECUTIVE MEMBERS FOR 2027-2028**

1. Members are hereby notified that, in accordance with Rules 61(i) and (ii) of the Constitution, nominations are invited for the 2027-2028 year as follows:

- a) President
- b) Junior Vice President
- c) Māori Vice President
- d) National Executive members in the following electoral areas:

- * The composition of these Wards, as ratified by the Executive, are attached as Appendix A and distributed to Tāmaki Makaurau Auckland Region branches only.

2. Any full member is eligible for nomination provided that (with the exception of the four Wards of the Tāmaki Makaurau Auckland Region) nominees for the Executive must be employed within the electoral area for which they are nominated. In the case of the four Wards of the Tāmaki Makaurau Auckland Region, the nominee may be a member of any branch in the Tāmaki Makaurau Auckland Region, but the nomination must be in respect of a specific Ward.
3. Where a member is nominated for the office of President and any other office, ballot papers and instructions will be issued so as to permit preferential voting for the candidates in that particular election.

At the conclusion of the voting, the votes cast will be counted in the order of President, Vice Presidents, Executive members, and the votes recorded against a candidate in an election for a lower office will not be counted if that person has been elected to the office of President.

4. Please note that the proposers and seconders of all nominations must be full members of the Association. Proposers and seconders of Executive member candidates (with the exception of President, Junior Vice President and Māori Vice President positions) must be members from within the electoral area concerned. Proposers and seconders for the Māori Vice President position must be from the Māori electoral roll.
5. Each year all candidates are asked to provide information about themselves (on the form supplied) with their nominations. This has a twofold purpose: it enables preparation of the election material without undue pressure and gives the Association information about all its office holders, even those for whom an election is not required. Presidential nominees should also supply a photo of themselves.
6. Candidates for the positions of President, Junior Vice President, Māori Vice President should submit a video up to 60 seconds in length [MX15/008]. The video must adhere to the **attached** 'Conduct of Association Elections – Note to All Candidates'. Specifically:
 - a) Avoid making 'personal policies' or 'policy platform' statements.
 - b) Do not canvass for support.
 - c) Demonstrate knowledge of te reo Māori (Māori Vice President nominations).
 - d) Please give full personal and biographical information of a factual and relevant nature to assist member voters.
7. Nominations close at 5.00 pm on Friday 28 August 2026. Nominations must be made on the **attached** form, with the written consent of the person nominated in the space provided. **All Nomination forms must be accompanied by the completed candidate's information sheet.**
8. The rolls for the purpose of any elections to be held following nominations will close at 5.00 pm on Wednesday 2 September 2026.
9. The forms of nomination to be used, together with material for candidates, are **attached**. Nominations should be emailed to returningofficer@ppta.org.nz before 5.00 pm on Friday 28 August 2026.

All candidates are asked to provide this information (on the form supplied) ***with their nominations***. This will have a twofold purpose: it will enable preparation of the election material without undue pressure on you and will give the Association information about all its office holders, even those for whom an election is not required. Please supply this material even if you have done so on a previous occasion.

Please return your contribution to this office, by email, with your nomination form.

Because of the limited time available to conduct the elections, there can be no extension of the deadline and if material is not received in time, publication of candidates' information will proceed without it.

1. Personal Information

Apart from name, age, etc., candidates may, if they wish, supply other personal information.

2. Professional Information

Give full and factual information with relevant dates, on:

- qualifications;
- training;
- Ngā Manu Kōrero, kapa haka and Māori teacher groupings (Māori Vice President nominations);
- professional history (include other occupations before you began teaching if you wish);
- current position and responsibilities.

3. Association Information

Give full and factual information, with relevant dates, on all aspects of involvement with PPTA or other teacher or employee association:

- membership;
- involvement at branch level;
- involvement at regional level and Te Reo o Rohe (Māori Vice President nominations);
- involvement at executive level and Te Huarahi (Māori Vice President nominations);
- involvement at regional level;
- involvement at executive level;
- other activities, i.e. association committees, curriculum panels, association representation, etc.

[**NOTE:** The Executive has resolved that all Executive members should endeavour to complete Stage 3 of PPTA's Employment Related Education Training and, if not already completed at the time of election, to complete Stage 2 – refs: MX04/01/19, MX04/01/20.]

4. Personal Statement - please use Te Reo Māori and English (Māori Vice President nominations).

Candidates are invited to make a statement on the lines along which they see the Association moving in the future. While current policy is as determined by the Annual Conference,

candidates may, if they wish, comment on the way in which they would like to see that policy change.

Candidates' statements may be up to 350 words. This statement will also be used on the PPTA website in respect of the President, Junior Vice President and Māori Vice President positions.

Emailed statements MUST be received by 5.00 pm on Friday 28 August 2026.

5. Photographs and Video

Candidates for the positions of President, Junior Vice President or Māori Vice President must provide an electronic copy of a photo of themselves to be used with the candidate profile sheets. The photo should be a headshot and not include anyone else. Candidates for President, Junior Vice President and Māori Vice President must also provide a video no longer than 60 seconds in length. **These also MUST be received by 5.00 pm on Friday 28 August 2026.**

Important Note

Your attention is drawn to the **attached** statement on the conduct of Association elections. This is based on legal opinion on the effects and implications of the Association's Constitution. The Returning Officer reserves the right to amend any candidate's statement which breaches the requirements set out in the note to candidates.

CONDUCT OF ASSOCIATION ELECTIONS – NOTE TO CANDIDATES

General

1. Pursuant to Rule 60 of the Constitution, the Executive has directed that the Returning Officer forward to each candidate a "code of conduct" in respect of Association elections.
2. The attention of candidates is drawn to the following Rules contained in the Association's Constitution:

Rule 48 (i):

The Annual Conference as hereby constituted shall have supreme authority in the Association.

Rule 38(i):

The Executive shall act for and on behalf of the Association between Conferences and in particular shall implement the decisions of and pursue the policies established by the Conference.

Rule 43(i) and 43(ii):

- i) All resolutions of the Executive and all acts and things duly done or executed in good faith shall be binding upon all members of the Executive whether present at any such meeting or not and upon all the property and assets of the Association PROVIDED that such resolution shall not be shown to be ultra vires the Executive AND PROVIDED FURTHER that all members of the Executive have been duly notified of such meeting.*
 - ii) The fact that any such resolution is made in pursuance of any decision or recommendation of the Conference shall be conclusive evidence of good faith and of the absence of any improper motive.*
3. It is clear from these extracts that the policy of the Association is determined by the Annual Conference, and, provided it is within the general policy guidelines established by the Conference, policy is also determined by the Executive.

There is, therefore, a clearly stated and democratic procedure by which the Association formulates and establishes its policies, and within this there can be no place for 'personal policies' or 'policy platforms' on the part of candidates for election to the Executive. You are reminded of this when making your personal statement.
 4. These rules apply also to Executive members once elected and in office.

Campaigning

5. The canvassing of other branches or members, whether by visiting for the purpose of addressing members or by the circulation of material, which may be related to the election, is excluded. This exclusion has been introduced in order to prevent any candidate obtaining an advantage due to his/her proximity to other Branches, other advantages of location, or the possession of a better financial status.
6. Canvassing for support and campaigning through the use of social media platforms (Facebook, Twitter, etc.) is also excluded. Candidates may encourage members to vote in an election and draw members' attention to where the profiles of all candidates, including the official video biographies, can be found. Candidates must not use social media to draw members' attention to the individual candidates. If any candidate is unsure of what is safe use of social media in Association elections, they are advised to err on the side of caution and contact the Returning Officer for advice or a ruling before posting.

7. However, candidates may address regional meetings (1990 conference decision). Any candidates wishing to take up this facility should contact the appropriate regional chairpersons and advise the Returning Officer of their intent. The Association will reimburse the actual costs reasonably incurred in attending such meetings.
8. Where elections are necessary the information supplied by candidates will be circulated to members to assist them in the process of voting.

- Avoid making 'personal policies' or 'policy platform' statements.
- Do not canvass for support.
- Please give full personal and biographical information of a factual and relevant nature to assist member voters.

1. Me whai ki te ture 60 o te kaupapa herenga ture, ko te mana o te Pou Ārahi Matua Whakahoki māna e tuku ki a ia kaitono tētahi “tikanga whanonga ki ngā pōtitanga aka haumi.
2. Me aro ngā kaitono ki ngā ture kāwanatanga e whai ake nei.

Ture 48 (i):

Ko te hui-ā-tau te tino rangatiratanga i roto i te aka haumi.

Ture 38(i):

Ko te kaiwhakahaere hoki te kaitakawaenga o te aka haumi i waenganui i ngā tīni huihuinga māna anō e whakauruuru ngā whakataunga ka kōrerotia i aua huihuinga matua.

Ture 43(i) me 43(ii):

- i) Ko ngā whakataunga kātoa o te manukura ka whakatautia i runga i te pono me te tika. He taura muka tāngata tēnei. Ahakoa kia kite i a ia i ngā huihuinga, aua whakataunga ōna he mea tiaki hoki i ngā rauemi me ngā taputapu nā Te Aka Haumi. Engari kaua e pohēhē ana i ngā whakataunga ōna he nui atu te mana i te mana o te whānau, me tino mārama mai ai rātou he aha te aha, e ahu pēhea ana te kaupapa.
 - ii) Ahakoa he whakataunga ōkawa, whai mana hoki nā te huihuinga te kōrero whakamutunga he mea ka tuku i runga i te aroha me te tika kia kaua a hē e whai whakaaro. Te āhua nei he whakataunga herenga i ahu mai i ngā hui-ā-tau, e pai ana tera engari me whai i ngā herenga aratohu me tautokona e te manukura aua whakataunga o te hui.
3. Waihoki e mārama ana he tikanga haumarua ka whakakohatutia e ngā rangatira o te aka haumi kia tika te tuku i ngā kaupapa herenga tapu. Nā reira ki ngā kaitono e kore ōu herenga ake e whai mana i roto i ngā pōtitanga. Me maumahara tēnei a te wā ka kōrero ai koe, ka tuhi raini ki te pepa tauākī.
 4. Ēnei ture mō te katoa, ahakoa tō tūranga i roto i te kaupapa.

Whakatairanga pōtitanga:
